ASSIGNMENT OF OIL AND GAS MINING LEASE  
STATE OF OKLAHOMA

Whereas, heretofore and on the 19th day of May, 1930, a certain Oil and Gas Mining Lease was made and executed by the Commissioners of the Land Office of the State of Oklahoma to Indian Territory Company, of Bartlesville in accordance with the laws of the State of Oklahoma, for a term of five years from said date, said lease covering the following described real estate and premises situated in the County of Oklahoma State of Oklahoma, to-wit: The East-half of the Southeast Quarter ( $E\frac{1}{2} SE\frac{1}{4}$ ) of Section 16, Township 14 North, Range 1 West and containing (80) Eighty acres, more or less, which said lands are State lands, and were by the said Commissioners of the Land Office declared to be valuable for oil and gas purposes, and the oil and gas deposits therein contained were by the said Commissioners of the Land Office segregated from the surface use and interest therein.

Now, Therefore, in consideration of the sum of One Dollar and other good and valuable consideration (\$1.00) Dollars, in hand paid, receipt of which is hereby acknowledged, and of the agreements and covenants herein contained, the said Indian Territory Company of Bartlesville State of Oklahoma, has sold, assigned, transferred and set over and does by these presents sell, assign, transfer and set over unto Indian Territory Illuminating Oil Company, their successors, heirs and assigns, all the rights, title and interest in and to the oil and gas leasehold estate created by said lease, insofar and only so far as the same relates to the lands described as follows, to-wit:
