Lots eleven (11) and twelve (12), twenty-five (25) and twenty-six (26) in Gray's Subdivision block nine (9). Lots five (5), six (6), Nine (9), Ten (10), seventeen (17), eighteen (18), thirty-one (31), thirty-two (32) block ten (10). (Lots three (3), and four (4), Fifteen and sixteen (16), twenty two, twenty-three (23) and twenty four (24), twenty-eight (28) thirty-one (31) and thirty-two (32), Block eleven (11).) Lots three (3) and four (4), Fifteen (15), and sixteen (16) Block Twelve (12). South seventy-five feet of lots one (1) and two (2); All of lots three (3) and four (4), Block thirteen (13). The South thirty feet of the west half of lot fourteen, and the south thirty feet of lots fifteen (15) and sixteen (16), (and all of lots seventeen (17) to twenty (20) inclusive, twenty-six (26), twenty-seven (27), twenty nine (29) block thirteen (13). Lot four (4) and the west ten feet of lot three (3), all of lots eleven (11) and twelve (12), twenty-four (24), and thirty-one (31) Block Fourteen (14). Lots two (2), three (3), six (6), seven (7), eight (8), thirteen (13), Seventeen (17), eighteen (18), twenty-one (21), twenty-two (22), and twenty-three (23) Twenty-nine (29) and thirty-two (32) Block fifteen (15).

The west 100 feet of lot one (1) block sixteen (16). All of lot two (2) Block Sixteen (16). The west fifty feet of lot three (3) block sixteen (16). Lots three (3) and four (4) in William's Subdivision of the east 350 feet of the south half of block sixteen (16), and lots nine (9) and ten (10) in William's Subdivision of the East 350 feet of the south half of block sixteen (16). Lots one (1) and two (2), Seven and eight (8), twenty-seven (27) to thirty-two (32) inclusive in the subdivision of the East half of block seventeen.

The East 75 feet of lot two (2) of the original plat of block seventeen (17), and all of lot three (3) of the original plat of block seventeen (17). All of block Eighteen (18).
