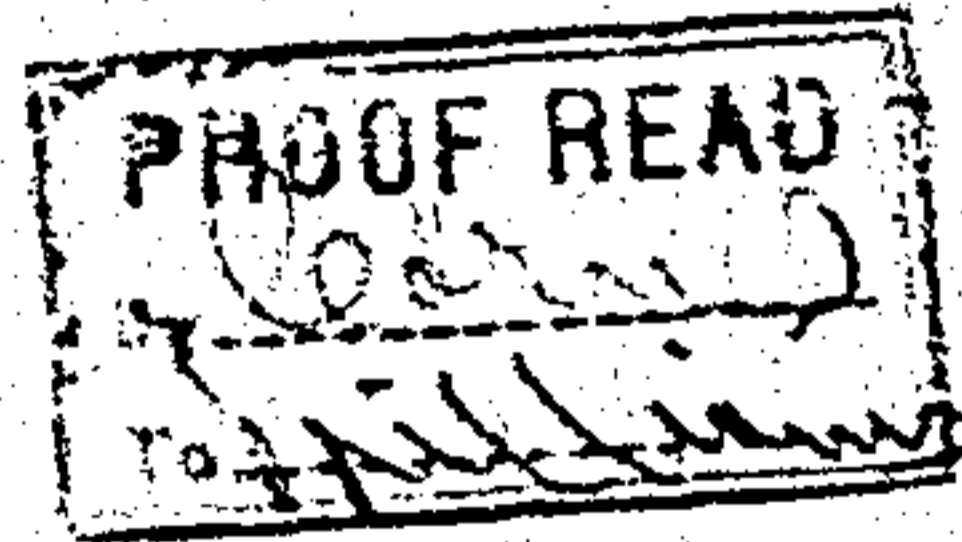

Whereas, J. M. Picow and Nathan Picow, are the sole owners of all of the lots and blocks in Wright Place Supplemental Adjacent to Wright, Oklahoma County, Oklahoma, according to the recorded plat thereof, the same being the South Half ($\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twelve (12) in Township Eleven (11) North, Range One (1) West of the Indian Meridian, and the plat thereof showing all the streets, alleys, lots and blocks into which the said described land was platted being recorded in Plat Book 19 at page 60 of the land title records of said Oklahoma County, to which as so recorded reference is hereby made; and
