ASSIGNMENT OF OIL AND GAS LEASES

WHEREAS, pursuant to the general corporation laws of the State of Delaware, in which state Sunray Oil Corporation and Transwestern Oil Company are chartered, a certain agreement of merger was entered into between said corporations, and on the 17 day of October, 1916, the same was approved by separate meetings of the stockholders of each of said Corporations by a vote of the holders of more than two-thirds of the capital stock of each said Corporations, which said agreement of merger has been duly filed and recorded of record as required by the laws of the State of Delaware, and under the terms and conditions of said merger agreement Transwestern Oil Company is merged into Sunray Oil Corporation, under the name and title of the latter, and Sunray Oil Corporation became and is the owner and holder of all properties and assets of Transwestern Oil Company, and

WHEREAS, assignments in writing are desirable to establish of record the title and ownership by Sunray Oil Corporation of the properties and assets of Transwestern Oil Company

NOW, THEREFORE, for and in consideration of the premises and other good and valuable considerations, the receipt of each and all of which is hereby acknowledged, the undersigned, as the present record owner of the leases and leasehold estates hereinafter described and of the interest hereinafter set forth, and as the owner of all rights thereunder, or incident thereto, does hereby bargain, sell, transfer, assign, convey, and set over unto SUNRAY OIL CORPORATION, a corporation of its right, title, interest and estate, and to the extent of its interest owned by the undersigned, all of the right, title, interest and estate of the original lessor and lessors in and to the following described oil and gas leases and leasehold estates insofar as the same cover the interests and the lands hereinafter set forth, located in the County of OKMAGONIA State of OKLAHOMA to wit:
