ASSIGNMENT OF OIL AND GAS MINING LEASE

WHEREAS, Willis Goldie Russell, as Trustee for Robert Taylor Russell, is the owner of an undivided seven-two hundred fifty sixths (7/256ths) interest in an oil payment lien of Two Hundred Fifty Thousand Dollars (\$250,000 00) against seven thirty-seconds (7/32nds) of the leasehold estate payable out of the well producing upon the following described tract situated in Oklahoma County, State of Oklahoma, to-wit

Lots 29, 30, 31 and 32 in Block 3, Spencer's South Oklahoma City Addition to Oklahoma City, Oklahoma, as shown by the recorded plat thereof,

and an additional and like amount payable out of a like interest from each and every well that may hereafter be drilled on any part of the above described oil and gas lease, said lease being recorded in Book 9 OGL, page 627, and re-filed and re-recorded in Book 19, page 304 in the office of the County Clerk of Oklahoma County, State of Oklahoma, in accordance with the terms of a certain assignment filed for record on August 30, 1934, and recorded in Book 203, page 140 in the office of the County Clerk of Oklahoma County, and

WHEREAS, the District Court of Oklahoma County, State of Oklahoma, in cause no 90675, and styled Frank Russell, plaintiff, vs Willis Goldie Russell, et al, defendants, on the 9th day of June, 1938, among other things, designated and appointed Frank Russell as Co-Trustee, in an advisory capacity only, with the said Willis Goldie Russell for the purpose of administering said trust, and

WHEREAS, by written agreement dated September 8, 1947, between Frank Russell, Trustee and Co-trustee and individually, and Willis Goldie Russell, Trustee and individually, Mrs Frank Russell, Trustee and individually, being one and the same person as Willis Goldie Russell, Willis Goldie Russell, cestui que trust and individually, Frank Russell, Jr, cestui que trust and individually, Robert Taylor Russell, cestui que trust and individually and Charles William Russell, cestui que trust and individually, a complete accounting was had of all of the trust assets and disbursements and it was agreed that said trust would be terminated as of that date and that the said trustees would convey to the respective cestui que trusts the interest in all properties due to each of them under the terms of the trust and various trust instruments and assignments, and

WHEREAS, pursuant to said agreement and a hearing in the United States District Court for the Western District of Oklahoma in cause no 2737, Civil, styled Frank Russell vs Willis Goldie Russell, et al, the said agreement last above referred to was examined and the court ordered the said case dismissed, subject to the filing of voluntary dismissals, and each party thereafter filed dismissals of said cause with prejudice

NOW, THEREFORE, in consideration of the aforesaid written agreement to dissolve the trusts and disburse the properties and proceeds thereof in accordance with said written contract and court order, the undersigned Willis Goldie Russell, as Trustee for Robert Taylor Russell, and Frank Russell, as Co-Trustee, do hereby bargain, sell assign, set over, transfer and convey to Robert Taylor Russell all of the interests described above in the several oil and gas leases and oil payment lien held by the said Willis Goldie Russell, as Trustee for the said Robert Taylor Russell, subject only to the terms of the several instruments by which the said Willis Goldie Russell, as Trustee for Robert Taylor Russell, acquired the same.

TO HAVE AND TO HOLD unto the said Robert Taylor Russell, in accordance with the terms of the several assignments

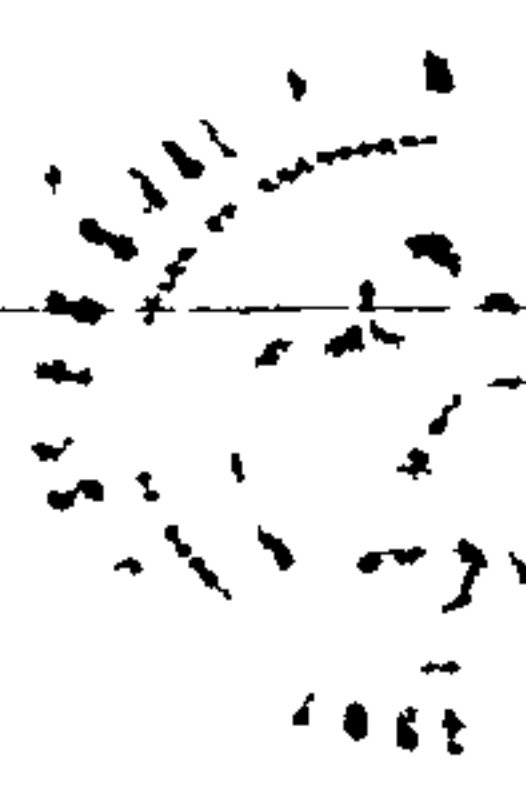
