Oil and Gas Lease dated April 23, 1949, executed by L. K. Montgomery and Bessie Montgomery, Lessors, in favor of F. L. Bishop, Lessee, recorded in the Office of the County Clerk of Oklahoma County, Oklahoma, in Book 1261, Page 417, covering

Blocks 165, 166 and 169, Interurban Addition to Jones City, Oklahoma, T13N, R1W, containing 15 acres, more or less.

together with the rights incident thereto and the personal property thereon, appurtenant thereto, or used or obtained in connection therewith.

Assignor herein excepts from this assignment and reserves unto himself, his heirs and assigns, an overriding royalty of one-sixteenth (1/16th) of seven-eighths (7/8ths) of the oil, gas, casinghead gas and hydrocarbons produced, saved and marketed from said leaseholds, free of all cost of whatsoever kind or nature, except such taxes as are applicable to said interest.

Fuel oil and gas produced from and used for operating the premises and/or lands pooled therewith and/or for treating and handling products therefrom shall be deducted before said overriding royalty is computed.

It is expressly agreed that the overriding royalty provided for above shall be receivable by Assignor on the production as above set out under the terms of said leases or under extensions of any primary term thereof. If lessors in any of said leases own interest in the premises covered thereby less than the entire and undivided fee, then as to such lease, the overriding royalty herein reserved shall be payable to Assignor only in the proportion which the interest of the lessor in such lease bears to the entire and undivided fee.

It is further agreed that Assignee shall be under no obligation by reason of the overriding royalty herein reserved, either to preserve said leases by rental payments, or to operate for the discovery, development or production of minerals; but all such rental payments and development operations, and the extent and duration thereof, as well as the preservation of each respective mineral leasehold estate shall be solely at the will of the Assignee herein.

Assignee, at his option, may without any further approval from Assignor, pool or combine the leases and lands

covered hereby, or any portion thereof, with other lands, lease or leases, in the immediate vicinity thereof, and in the event the leases and lands affected hereby, or any portion thereof, are pooled or combined with the lease or leases on other lands to comprise a unit, Assignor herein shall receive on production in lieu of the overriding royalty herein specified only such portion of the overriding royalty stipulated herein as his overriding royalty interest in the land included in such unit, on an acreage basis, bears to the total acreage so pooled in the particular unit involved.

And for the same consideration the Assignor covenants with the Assignee, his heirs and assigns: That the Assignor is the lawful owner of and has good title to the interest above assigned in and to said leases, estates, rights and property, free and clear from all liens, encumbrances or adverse claims; That said leases are valid and subsisting leases on the lands above described, and all rentals and royalties due thereunder have been paid and all conditions necessary to keep the same in full force have been duly performed; and that the Assignor will warrant and forever defend the same against all persons whomsoever lawfully claiming or to claim the same, by, through or under Assignor only.

The provisions hereof shall be binding upon and inure to the heirs, legal representatives and assigns of each, the assignor and the assignee.
