JOURNAL ENTRY

On this 12th. day of November, 1954, this cause coming on for hearing upon the petition of Ralph Douglas and others, for the organization of a conservancy district under the Conservancy Act of the State of Oklahoma, the court after a full hearing now here finds:

That a sufficient number of qualified landowners in each of the counties involved have signed the petition and that the total number of land owners signing the petition is sufficient as required under the Conservancy Act of the State of Oklahoma and that this court hath jurisdiction of the parties to, and the subject matter of this proceedings.

That the purposes for which said district is established are:

- (a) Of preventing floods;
- (b) Of regulating stream channels by changing, widening and deepening same;
- (c) Of reclaiming or of filling wet and overflowed lands;
- (d) Regulating the flow of streams;
- (e) Of diverting, or in whole or in part eliminating, water courses or part of the flowage thereof;
- (f) To maintain, operate and repair any of the construction herein named, and to do all other things necessary for the fulfillment of the purposes of this petition.

And that it is a public necessity.

That the public safety, health, convenience and welfare will be promoted by the organization of a conservancy district substantially as prayed in said petition as amended.

That the general boundaries of said conservancy district, and the territory to be included in such district until specifically delimited by the viewers and engineers are as follows:

Beginning at the Northwest corner of Section 24, Township 16 North, Range 2 West, thence South along the township line a distance of three (3) miles to the Southwest corner of Section 36, Township 16 North, Range 2 West, thence East a distance of one (1) mile to the Northwest corner of Section 2, Township 15 North, Range 2 West, thence South a distance of two (2) miles to the Southwest corner of Section 11, Township 15 North, Range 2 West, thence East a distance of two (2) miles to the Southeast corner of Section 12, Township 15, North, Range 2 West, thence South a distance of one (1) mile to the Southwest corner of Section 18, Township 15 North, Range 1 West, thence East a distance of one (1) mile to the Southeast corner of Section 18, Township 15 North, Range 1 West, thence South a distance of one (1) mile to the Southwest corner of Section 20, Township 15 North, Range 1 West, thence East a distance of one (1) mile to the Southeast corner of Section 20, Township 15 North, Range 1 West, thence South a distance of one (1) mile to the Southwest corner of Section 28, Township 15 North, Range 1 West, thence East a distance of one (1) mile to the Southeast corner of Section 28, Township 15 North, Range 1 West, thence South a distance of one (1) mile to the Southwest corner of Section 34, Township 15 North, Range 1 West, which is on the county line between Logan County and Oklahoma County, thence East a distance of one (1) mile to the Southeast corner of Section 34, Township 15 North, Range 1 West, thence South a distance of two (2) miles to the Southwest corner of Section 11, Township 14 North, Range 1 West, thence East a distance of one (1) mile to the Southeast corner of Section 11, Township 14 North, Range 1 West, thence South a distance of one (1) mile to the Southwest corner of Section 13, Township 14 North, Range 1 West, thence East a distance of one (1) mile to the Southeast corner of Section 13, Township 14 North, Range 1 West, thence South a distance of two (2) miles to the Southwest corner of Section 30, Township 14 North, Range 1 East.

thence East a distance of four (4) miles to the Southeast corner of Section 27, Township 14 North, Range 1 East, thence North a distance of two (2) miles to the Southwest corner of Section 14, Township 14 North, Range 1 East, thence East a distance of one (1) mile to the Southeast corner of Section 14, Township 14 North, Range 1 East, thence North a distance of one (1) mile to the Northeast corner of Section 14, Township 14 North, Range 1 East, thence East a distance of four (4) miles to the Southeast corner of Section 9, Township 14 North, Range 2 East, thence North a distance of four (4) miles to the Southwest corner of Section 22, Township 15 North, Range 2 East, thence East a distance of one (1) mile to the Southeast corner of Section 22, Township 15 North, Range 2 East, thence North a distance of five (5) miles to the Northeast corner of Section 34, Township 16 North, Range 2 East, thence West a distance of one (1) mile to the Northwest corner of Section 34, Township 16 North, Range 2 East, thence North a distance of two (2) miles to the Northeast corner of Section 21, Township 16 North, Range 2 East, thence West a distance of four (4) miles to the Southeast corner of Section 14, Township 16 North, Range 1 East, thence North a distance of one (1) mile to the Northeast corner of Section 14, Township 16 North, Range 1 East, thence West a distance of ten (10) miles to the Northwest corner of Section 17, Township 16 North, Range 1 West, thence South a distance of one (1) mile to the Southwest corner of Section 17, Township 16 North, Range 1 West, thence West a distance of two (2) miles to the Northwest corner of Section 24, Township 16 North, Range 2 West, the same being the point of beginning and describing a closed survey in Logan, Oklahoma and Lincoln Counties, consisting of approximately one hundred eighty seven (187) sections, more or less. (Less Sections Six (6), Seven (7) and Nine (9) in Township Fourteen (14) North, Range Two (2) East of the Indian Meridian, previously stricken from the petition by order of the court.)

That the said territory last above described should be erected into and created a conservancy district under the Conservancy Act of the State of Oklahoma under the corporate name of "Bear, Fall and Coon Creeks Water and Soil Conservancy District No. 4", with its principal place of business at Guthrie in Logan County, Oklahoma.

And the following persons are hereby appointed directors of said conservancy district, until their successors are elected and qualified:

Loren Briscoe, a farmer, whose address is Route 1, Luther, Oklahoma;

George Gillian, a civil engineer, whose address is Chandler, Oklahoma,

Charlie Wilson, a farmer, whose address is Luther, Oklahoma

Said directors being residents of Logan, Lincoln, and Oklahoma counties, respectively, all in Oklahoma, and who are hereby directed to qualify and proceed according to law.

For consideration of other matters herein, this course is retained on the docket.
