

ORDINANCE NO. 1 - 1966

AN ORDINANCE PROVIDING FOR THE ANNEXATION TO THE TOWN OF HARRAH, OKLAHOMA, OF THE LAND HEREIN DESCRIBED AND EXTENDING THE BOUNDARIES TO INCLUDE SAID LAND: MAKING JURISDICTIONAL FINDINGS OF FACT, PROVIDING THAT IF ANY PART OR PARTS HEREOF BE HELD INVALID OR INEFFECTIVE THE REMAINING PORTIONS SHALL NOT BE AFFECTED AND DECLARING AN EMERGENCY.

(EMERGENCY ORDINANCE)

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF HARRAH, OKLAHOMA:

Section 1. That whereas, consent in writing and petitions for annexation of land having been presented to the Board of Trustees of the Town of Harrah, Oklahoma, by more than three fourths (3/4ths) of the owners in value of all land territory herein described and signed by more than three fourths (3/4ths) of the legally qualified voters living thereon, requesting the annexation to the Town of Harrah, Oklahoma, of all the following land and territory situated in Oklahoma County, State of Oklahoma, to-wit:

All of sections one (1), two (2), three (3), four (4), five (5), eight (8), nine (9), ten (10), eleven (11), twelve (12), thirteen (13), sixteen (16), seventeen (17), twenty-four (24), twenty-five (25), and thirty-six (36), in Township Twelve (12) North, Range One (1), East of the I.M. Oklahoma County, Oklahoma.

Town of Harrah, Oklahoma be and they are extended to include all of the above land and territory, A copy of this ordinance, duly certified by the President of the Board of Trustees of the Town of Harrah, Oklahoma, shall be filed in the office of the County Clerk of Oklahoma County, State of Oklahoma together with an accurate map of the territory annexed.

Section 3. That if any part hereof be invalid or ineffective the remaining portion of this ordinance shall not be ~~effective~~ affected.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. (Emergency) WHEREAS, it being immediately necessary for the preservation of peace, health, and safety of the Town of Harrah, Oklahoma, and the inhabitants thereof, the provisions of this ordinance be put in full force, and effect and an emergency is hereby declared to exist by reason thereof this ordinance shall take effect and be in full force and effect from and after passage provided by law.

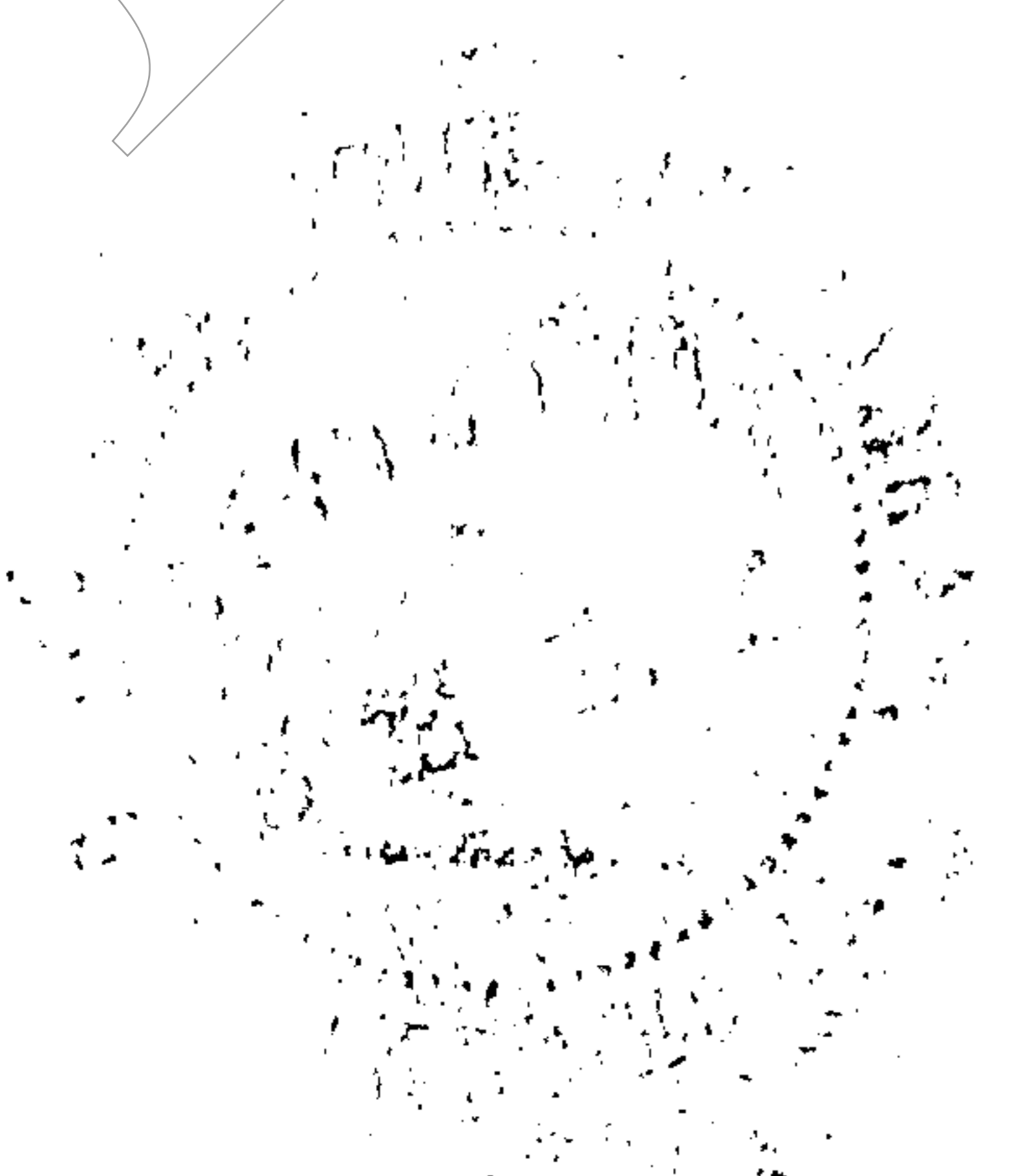

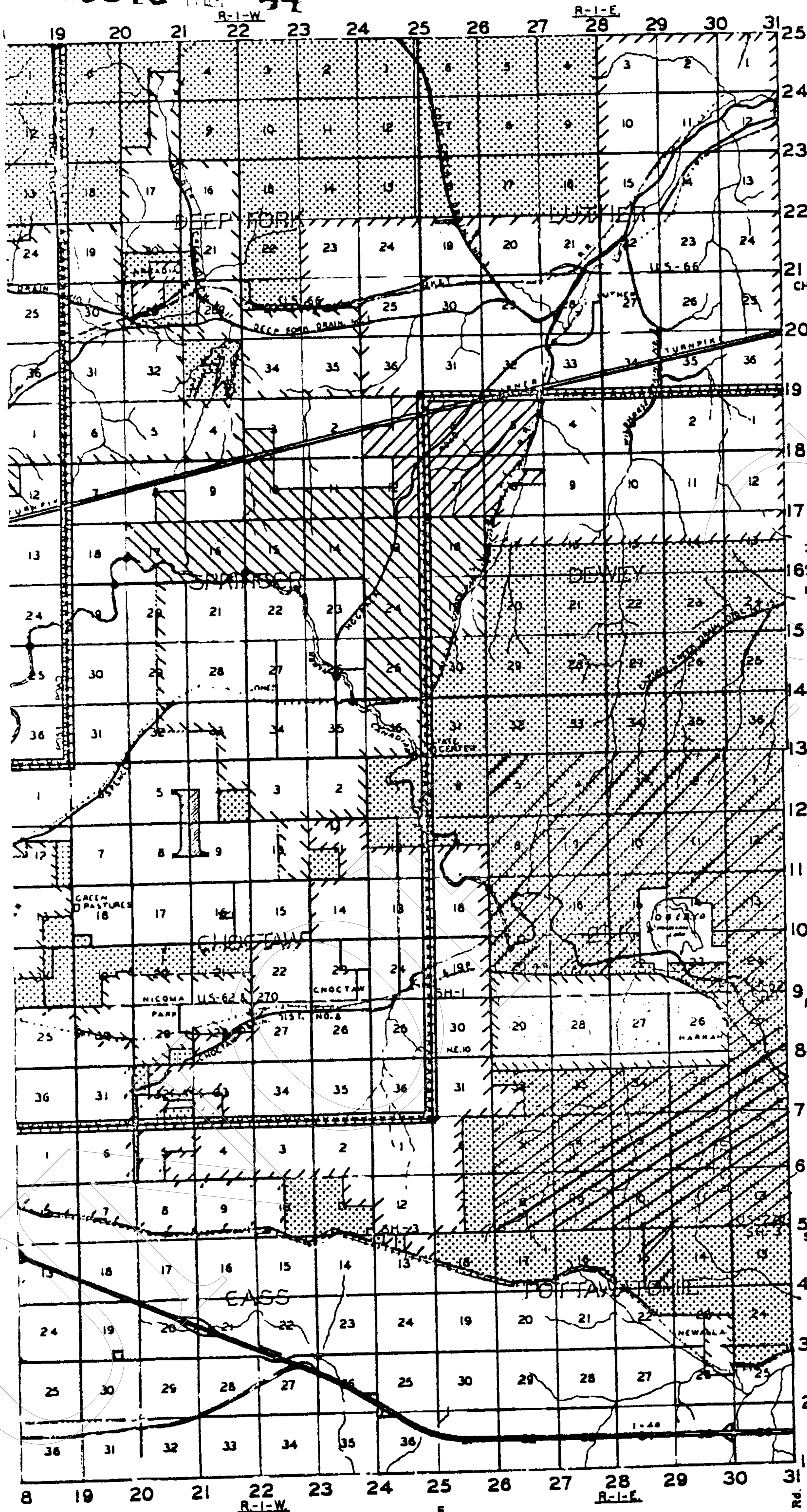
