The Oklahoma Water Resources Board establishes this order, under the authority of Title 82, Oklahoma Statutes Supp. 1973, Sections 1085.2, 1020.14, and OWRB Rules, Regulations and Modes of Procedures, Chapter VIII, Sections 875.1 - 875.17. The Oklahoma Water Resources Board has considered all active ground water application files; all known claims by persons not having previously filed an application; all evidence filed at the public hearing held at the Conference Room, Oklahoma Water Resources Board, on October 29, 1980; and all evidence filed with the Oklahoma Water Resources Board postmarked prior to 12:00 a. m. December 29, 1980.

Prior rights determined by the Oklahoma Water Resources Board shall be exercised only through wells located upon the parcel of land relied upon for perfection of such right and which was leased or owned by the right holder on the date of the priority of the right. Any wells drilled prior to July 1, 1973, which did not perfect a prior right under Title 82 O. S. Supp. 1973, Section 1020.4, and any wells drilled after July 1, 1973, the effective date of the ground water act, must be approved by the Board. (82 O. S. Supp. 1973, Sections 1020.1 - 1020.22 and OWRB Rules, Regulations and Modes of Procedure, Chapter VIII, Section 875.15).

Any appeal of this order must be taken within thirty (30) days after receiving notification of such order as provided in the Oklahoma Administrative Procedures Act (75 O. S. Supp. 1971, §301 et seq. as amended) and shall either be made through the District Court for the County in which the party seeking review resides or through the District Court for the county where the property interest affected is situated.




