AFFIDAVIT OF POOLING

Pursuant to Title 52 O.S., Section 87.1 (e) (1977), (1982) (Forced Pooling)

Carla Albright, Affiant of lawful age being first duly sworn, deposes and says as follows: I am employed by Fremont Energy Corporation, whose address is 3030 Northwest Expressway, Suite 1602, Oklahoma City, Oklahoma 73112, in the capacity of Landman, and further that in said capacity facilitated Fremont Energy Corporation in filing an Application to Pool and Fix and Determine Equities under Cause CD No. 950000300 dated January 27, 1995, amended by Application filed and dated February 6, 1995, and heard on February 27, 1995. Following said hearing Order No. 390572 dated March 9, 1995, resulted in the following:

To pool and adjudicate the rights and equities of the owners named in Exhibit "A" attached hereto, underlying the lands described as the NE/4 of Section 26, Township 11 North, Range 1 East, Oklahoma County, Oklahoma, for the following common sources of supply:

Said owners named in Exhibit "A" attached hereto are accorded the following elections:

6.1 Participate: To participate in the development of the unit and common sources of supply by agreeing to pay such owner's proportionate part of the actual cost of the well covered hereby and by paying, as set out below, to Operator such owner's proportionate part of the estimated completed for production cost thereof, or by securing or furnishing security for such payment satisfactory to the Operator, within 20 days from the date of this Order, as follows:

Completed as a dry hole	\$217,350
Completed for production	\$299,470

provided, however, that in the event an owner elects to participate in said well by paying his proportionate part of the costs thereof and fails or refuses to pay or to secure the payment of such owner's proportionate part of the completed for production cost as set forth herein, or fails or refuses to pay or make an arrangement with the Operator for the payment thereof, all within the periods of time as prescribed in this Order, then such owner shall be deemed to have elected to accept the cash bonus as set out in paragraph 6.2 below; provided, that if an owner's interest has burdens that exceed the normal 1/8 royalty interest provided in paragraph 6.2 below, then in that event such owner shall be deemed to have accepted the option provided in paragraph 6.3 below. Thereupon, the payment of such cash bonus shall be made by Operator within 30 days after the last day of which such defaulting owner, under this Order, should have paid his proportionate part of such costs or should have made satisfactory arrangements for the payment thereof.

6.2 Cash Consideration: To accept \$70.00 per acre as a fair, reasonable, and equitable bonus to be paid unto each owner who elects not to participate in said well by paying such owner's proportionate part of the cost thereof; such cash bonus to be paid within 30 days from the date of this Order and when so paid shall be satisfaction in full for all rights and interests of such owner in the entire drilling and spacing unit and the well or wells covered hereby, except for any normal 1/8 royalty interest as defined in 52 O.S., Section 87.1 (e) (1982).

6.3 Cash Consideration: In lieu of the cash bonus as set out in paragraph 6.2 above, an owner may elect to accept \$50.00 per acre plus an

overriding royalty or excess royalty of 1/16 of 8/8 as a fair, reasonable, and equitable bonus to be paid unto each owner who elects not to participate in said well by paying such owner's proportionate part of the cost thereof; such cash bonus to be paid within 30 days from the date of this Order and when so paid shall be satisfaction in full for all rights and interests of such owner in the entire drilling and spacing unit and the well or wells covered hereby, except for any normal 1/8 royalty interest as defined in 52 O.S., Section 87.1 (e) (1982); provided, however, in the event any owner's interest is subject to a royalty, overriding royalty, or other burden on production in excess of the normal 1/8 royalty as defined herein, then such excess royalty, overriding royalty, or other burden shall be charged against the 1/16 of 8/8 overriding or excess royalty as herein set forth, and the same shall be reduced by the amount of any such excess.

Provided, however, in the event the oil and gas interest of any owner is subject to any royalty, overriding royalty, or other payments out of production which create a burden on such interest in excess of the normal 1/8 royalty as provided for in paragraph 6.2 above, the owner of such interest shall not be entitled to the cash bonus provided in paragraph 6.2 above, but shall be required to either participate or to accept the additional royalty provided in paragraph 6.3 above, in all events such excess royalty, overriding royalty, or other payments out of production should be charged against the overriding or excess royalty, or overriding royalty, as hereinabove set forth, and same should be reduced by the amount of any such excess.

In the event any owner fails to elect within a timely manner, then such owner shall be deemed to have accepted the cash bonus as set out in paragraph 6.1 above; provided, that if an owner's interest has burdens that exceed the normal 1/8 royalty interest provided in paragraph 6.2 above, then such owner shall be deemed to have accepted the option provided in paragraph 6.3 above.


The elections as referenced above are subject to further conditions set out in Order No. 390572 filed before the Corporation Commission of the State of Oklahoma.

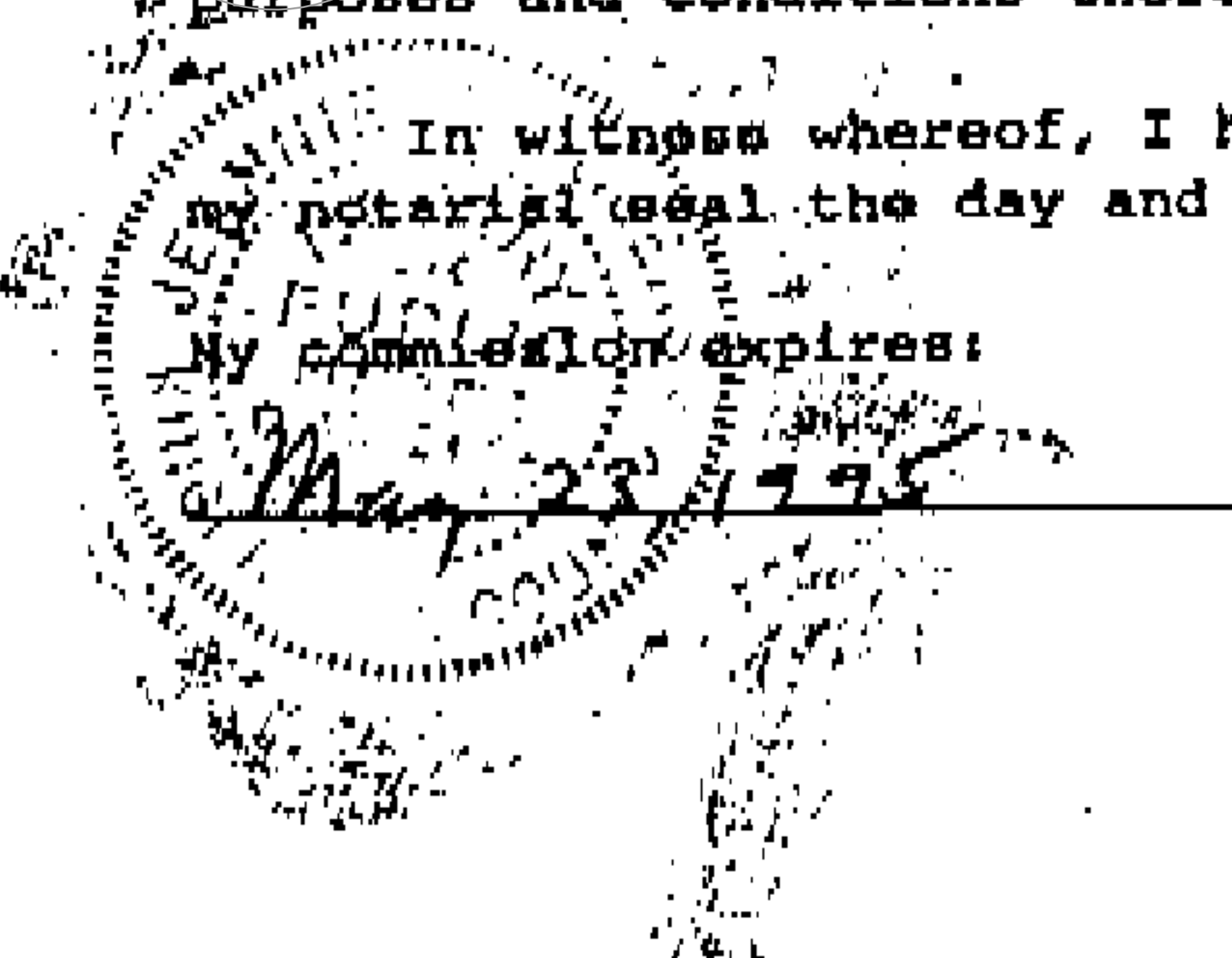
