1. Reference is made to that certain Deed of Trust, Mortgage, Line of Credit Mortgage, Assignment, Security Agreement, Fixture Filing and Financing Statement, dated March 1, 2003, from EOTT Energy Operating Limited Partnership, EOTT Energy Pipeline Limited Partnership and EOTT Energy Liquids, L.P. Chicoine, as Trustee, and Standard Chartered Bank, as Collateral Agent ("Agent"), ("Mortgage", a counterpart of which is recorded, among other places, in the records of the Counties and Parishes in the States, all as set forth on Exhibit A, and the recording information for each such County and Parish is also set forth on Exhibit A), as amended by that certain First Supplement and Amendment to Deed of Trust, Mortgage, Line of Credit Mortgage, Assignment, Security Agreement, Fixture Filing and Financing Statement, dated December 29, 2003, from Link Energy Limited Partnership, Link Energy Pipeline Limited Partnership, and EOTT Energy Liquids, L.P. ("Mortgagor") to Trustee and Agent ("First Amendment"), a counterpart of which is recorded, among other places, in the records of the Counties and Parishes in the States, all as set forth on Exhibit A (and the recording information for each such County and Parish is also set forth on Exhibit A).

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the undersigned has RELEASED and DISCHARGED, and by these presents does hereby RELEASE and DISCHARGE the "Mortgaged Properties", the "Collateral" and "proceeds of Collateral" (as such terms are defined in the Mortgage and First Amendment) from the liens and security interests created by the Mortgage and First Amendment. The undersigned hereby terminates the assignment of "Rents" made in favor of the undersigned under Article III of the Mortgage and Section 4 of the First Amendment.

It is expressly understood that certain indemnification obligations and other obligations of Mortgagor are, as provided in the Mortgage and First Amendment, to survive any release of the Mortgage and First Amendment, and that such obligations are not released or otherwise affected hereby.

This Release is executed in counterparts, all of which are identical except that to facilitate recording in the states of Kansas, North Dakota, and Oklahoma, there may be attached to counterparts of this Release which are being recorded in such states copies of Exhibit A to the Mortgage and First Amendment. All such counterparts constitute one and the same instrument.

By accepting receipt of this Release, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Mortgagor does hereby, for itself and its
