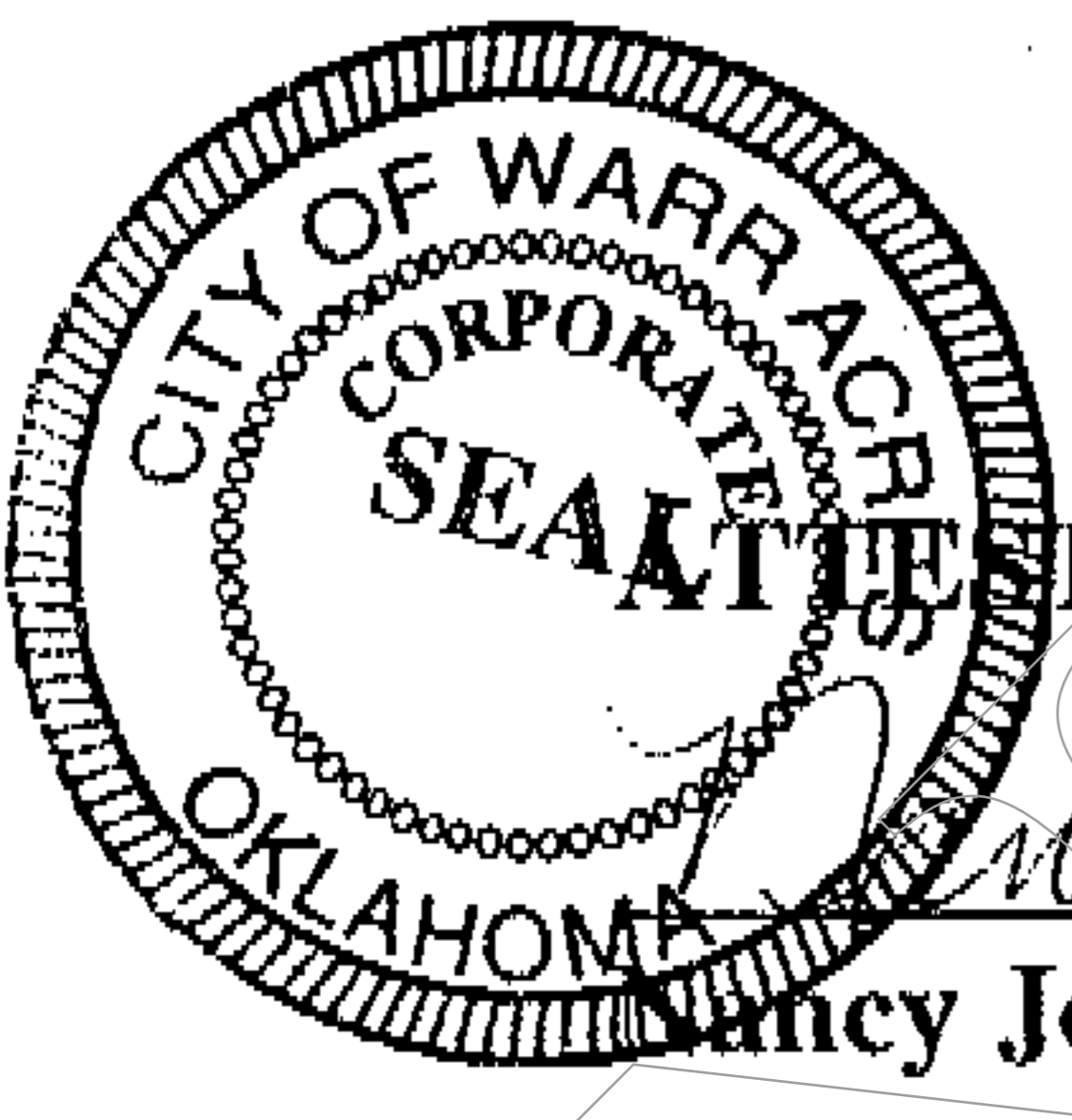
WHEREAS, THE CITY OF WARR ACRES, OKLAHOMA, ACTING

ACRES MUNICIPAL CODE 1977" AS REQUIRED BY LAW, AND;

NOW, THEREFORE, BE IT RESOLVED THAT ONE COPY OF THE  
SUPPLEMENTS TO THE CITY CODE BE FURNISHED TO THE COUNTY  
LAW LIBRARY OF OKLAHOMA COUNTY, OKLAHOMA AND COPIES OF  
THE RESOLUTION BE FURNISHED AND FORWARDED TO THE COUNTY  
CLERK OF OKLAHOMA COUNTY.
