This Conveyance is dated to be effective as of September 1, 2006, at 12:01 A.M., local time (the "Effective Time") and is by and between **Windom Royalties LLC, a Texas Limited Liability Company, a subsidiary of Noble Royalties, Inc., a Texas Corporation** (hereinafter referred to as "Grantor"), whose address is 15601 Dallas Parkway, Suite 900, Addison, TX 75001, and Grantees, as hereinafter defined.

RECITALS

(A) The term "Interests" shall be defined as all of the mineral interests, royalty interests, and/or overriding royalty interests in and to all of the leases, lands, depths and wells which are described in and conveyed by the "Assignments", as hereinafter defined.

(B) The term "Assignments", as used herein, shall be defined as all of the instruments of conveyance and/or assignments listed on **Exhibit A** attached hereto and incorporated herein for all purposes, which Assignments cover certain mineral interests, royalty interests and/or overriding royalty interests in and to the leases, lands, depths and wells more particularly described and/or referred to therein.

(C) The term "Grantees", as used herein, shall be defined as all those individuals and entities listed in the column entitled "GRANTEE NAME" on **Exhibit B** attached hereto and incorporated herein for all purposes.

(D) To the extent required for recording in any particular county in which any land affected by any of the Assignments is located, a legal description of land comprising all or any portion of the Interests subject to such requirement is set forth on **Exhibit C** attached hereto and incorporated herein for all purposes.

This Conveyance is being executed pursuant to, and is subject to the terms and provisions of, the following agreements:

- (1) Those certain Participation Agreements dated as of the Effective Time, by and between Grantor and Grantees, reference to which is here made for all purposes, and
- (2) Those certain Management Agreements with Power of Attorney (collectively, the “Management Agreements”) dated as of the Effective Time, by and between Compass Royalty Management LLC and Grantees, reference to which is here made for all purposes.

Notwithstanding anything contained herein to the contrary, the parties hereto do hereby UNDERSTAND, ACKNOWLEDGE and AGREE as follows:

1. GRANTOR HAS NOT MADE, AND GRANTOR HEREBY EXPRESSLY DISCLAIMS AND NEGATES, AND GRANTEEES HEERBY EXPRESSLY WAIVE ANY REPRESENTATION OR WARRANTY, EXPRESS, IMPLIED, AT COMMON LAW, BY STATUTE OR OTHERWISE RELATING TO (A) THE ACCURACY, COMPLETENESS OR MATERIALITY OF ANY INFORMATION, DATA OR OTHER MATERIALS (WRITTEN OR ORAL) NOW, HERETOFORE OR HEREAFTER FURNISHED TO GRANTEEES BY OR ON BEHALF OF GRANTOR, (B) THE ACCURACY OF ANY DATA OR RECORDS CONCERNING THE QUALITY OR QUANTITY OF OIL, GAS OR OTHER HYDROCARBON RESERVES, IF ANY, ATTRIBUTABLE TO THE INTERESTS, (C) THE ENVIRONMENTAL

CONDITION OF THE INTERESTS, (D) ANY STATUTORY, EXPRESS OR IMPLIED WARRANTY OF MERCHANTABILITY, (E) ANY STATUTORY, EXPRESS OR IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, (F) ANY STATUTORY, EXPRESS OR IMPLIED WARRANTY OF CONFORMITY TO MODELS OR SAMPLES OF MATERIALS, AND (G) ANY AND ALL STATUTORY, EXPRESS OR IMPLIED WARRANTIES EXISTING UNDER APPLICABLE LAW. IT IS THE EXPRESS INTENTION OF BOTH GRANTOR AND GRANTEES THAT THE UNDIVIDED INTEREST IN AND TO THE INTERESTS BEING CONVEYED HEREUNDER IS HEREBY CONVEYED TO GRANTEES IN ITS PRESENT CONDITION AND STATE OF REPAIR "AS IS" AND "WHERE IS" AND "WITH ALL FAULTS", THAT WITH RESPECT TO SUCH MATTERS GRANTEES ARE RELYING SOLELY UPON THEIR OWN INVESTIGATION AND THAT AS OF THE ACCEPTANCE OF DELIVERY OF THIS CONVEYANCE GRANTEES WILL HAVE MADE OR CAUSED TO BE MADE SUCH INSPECTIONS AS GRANTEES DEEM NECESSARY, ADVISABLE OR APPROPRIATE. GRANTOR AND GRANTEES AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW TO BE EFFECTIVE, THE DISCLAIMERS OF CERTAIN WARRANTIES CONTAINED HEREIN ARE "CONSPICUOUS" DISCLAIMERS FOR THE PURPOSES OF ANY APPLICABLE LAW, RULE OR ORDER.

2. Notwithstanding anything contained herein to the contrary, unless or until Grantees or a Grantee shall cause a notice, certificate, affidavit or other instrument to be filed for record in the county or counties in which the Interests are located, Grantor shall have the right and each of the Grantees does hereby direct and authorize Grantor to collect and receive direct from any entity purchasing the oil, gas or other hydrocarbons produced, saved, sold and/or marketed from and/or attributable to the Interests (or any other purchaser of such production) all of Grantees' interests in the proceeds from the sales of same. Grantor shall receive such proceeds as the Agent for Grantees and, after deducting therefrom all sums due and owing by Grantees to Grantor, if any, remit the balance of said proceeds, if any, to Grantees, such remittance to be by Grantor's check forwarded or mailed to Grantees; provided, however, that no third party purchaser of production shall be required to see the application by Grantor of any proceeds paid to Grantor hereunder and such third party purchaser shall have no liability to Grantees or anyone claiming by, through or under Grantees by reason of the payment of such proceeds to Grantor, as the Agent for Grantees, as herein provided unless and until such third party purchaser shall have received a recorded copy of the above referenced notice, certificate, affidavit or other instrument. Nothing contained herein shall be deemed a transfer of title to Grantees' share of the proceeds herein described and, to the extent the proceeds received by Grantor for Grantees' account exceed the amounts then due by Grantees to Grantor as described above, if any, such proceeds shall remain the property of Grantees until paid over by Grantor to Grantees. Grantor shall have the right to commingle proceeds received by it with other similar proceeds received by Grantor. Notwithstanding anything contained in this provision to the contrary, the terms and provisions of this provision shall not create a fiduciary relationship, whether legal or quasi-legal, whereby Grantor can be held liable for breach of such relationship. Grantor hereby reserves any and all surface rights, possessory rights, net profit interests and so-called "working interests", which rights and interests are not intended to be transferred to the Grantees.

Michigan Properties Only, if any: The Grantor grants to Grantees the right to make zero divisions under Section 108 of the Land Division Act, Act No. 288 of the Public Acts of 1967. This property may be located within the vicinity of farmland or a farm operation. Generally acceptable agricultural and management practices which may generate noise, dust, odors and other associated conditions may be used and are protected by the Michigan right to farm act.

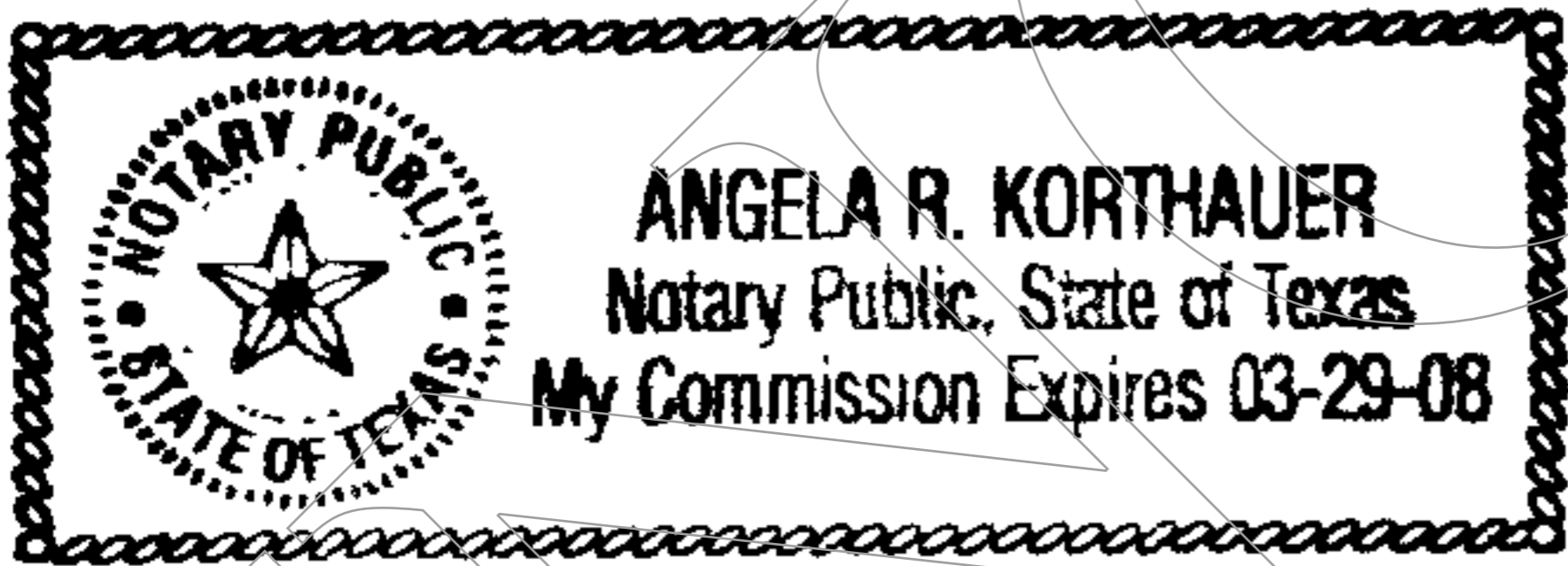
